- Consultant Report
 - o FAA. Master Plan Commissioners in agreement Continue using 2007 Master Plan, renovations to fix up current the current runway. Scott speaking w/FAA in Detroit to convey as much.
 - 2007 Priority of plan updates we will address? Annual AIP updates to be added to AWAS, eliminated with "new" "Master Plan" (2016/2017). How will recommendations be implemented? i.e., addressing water/drainage issues.
